A document fee of £150 will be collected with your first rental.

**What are my options at the end of the lease?**

1. At the end of the lease, you sell the vehicle on behalf of the leasing company and retain 95% of the proceeds of the sale. This can be by way of part exchange, or sale to a third party VAT registered business
2. You can extend the lease for an additional year for one months rental per additional year .
3. If your lease has a final rental, (balloon), you can sell the van as a PX or to a third party, settle the outstanding payment from the proceeds of the sale( Less 5% charge) and put the balance towards your next van, or take the money.

**Do I have mileage restrictions or face conditions of use and end of contract charges?**

1. The van will be registered in your name.
2. You have no mileage restrictions or restrictions on use. However It is not good business practice to have a lease with a final rental ( Balloon) if you use your van heavily, enter into a five year lease or do 50,000 miles a year.
3. You are responsible for the sale of the vehicle at the end of the agreement. If the van is in good condition at the end of the agreement, your bank balance will benefit .

**Can I cancel the agreement or change the vehicle early?**

Provided the outstanding balance is settled you can close the agreement at any time. Unlike contract hire there are no penalty charges. Provided there is enough value in the vehicle you can part exchange at any time and set up a new agreement.

**I can get it cheaper on the Internet!**

We can play around with the structure of the lease to reduce the monthly payment, but you will end up with a bigger deposit, a bigger final rental , a longer term, or if you are really unlucky, all three. **Cheaper does not mean you pay less money!** We try to make our lease quotes reflect best industry practice at all times.
